



ARTICLES OF AMENDMENT

AT&T Global Information Solutions Company, a Maryland Corporation having its principal business office in Dayton, Ohio, and its principal office in the City of Baltimore, State of Maryland (hereinafter called the Company) hereby certifies to the State Department of Assessments and Taxation of Maryland, that:

FIRST: The charter of the Company is hereby amended by striking out the present Article Second of the Charter, as heretofore amended, and inserting in its place a new Article Second which shall read as follows:

Second: The name of the Corporation (which is hereinafter termed the Company) is

NCR Corporation

SECOND: The Board of Directors of the Company by unanimous written consent pursuant to Section 2-408 of Corporations and Associations Article of the Annotated Code of Maryland on January 9, 1996 duly adopted a resolution in which was set forth the foregoing amendment to the Charter, declaring that the said amendment of the Charter as proposed was advisable and directing that it be submitted for action thereon by the stockholder of the Company.
