CERTIFICATE OF INCORPORATION**

Pursuant to the provisions of Section 242 of the Delaware General Corporation Law (the "DGCL"), Waugh Acquisition Corporation, a Delaware corporation (the "Corporation"), hereby adopts the following Certificate of Amendment to its Certificate of Incorporation:

**Article I**

The name of the corporation is Waugh Acquisition Corporation.

**Article II**

An amendment changing the name of the Corporation was adopted by the shareholders of the Corporation on January 18, 1995. The Amendment changes Article I of the original Certificate of Incorporation such that Article I, as so altered, reads in its entirety as follows:

The name of the corporation is Waugh Controls Corporation.

**Article III**

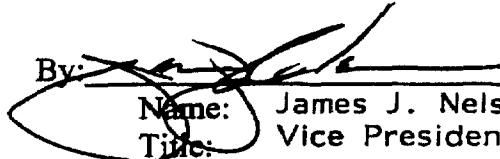
