RELEASE OF SECURITY INTEREST

WHEREAS, reference is made to that certain Facility Agreement, dated October 17, 1997 (as amended, supplemented or otherwise modified from time to time, the "Facility Agreement"), among, *inter alia*, M.A.I.D. plc, a corporation organized under the laws of England ("M.A.I.D."), certain companies identified therein as Borrowers, Guarantors and Banks, and Chase Manhattan International Ltd. (in such capacity as security agent for the Secured Beneficiaries (as defined therein), "Security Agent");

WHEREAS, reference is also made to that certain U.S. Security Agreement, dated November 14, 1997 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among M.A.I.D., certain companies identified therein as U.S. Obligors (collectively with M.A.I.D., "Grantors") and Security Agent;

WHEREAS, pursuant to the Security Agreement, each Grantor granted to Security Agent a security interest in all of such Grantor's right, title and interest in and to such Grantor's trademarks, including the trademark registrations and applications for registration listed in Schedule A hereto ("Trademarks"), and copyrights, including the copyright registrations and applications for registration listed in Schedule B hereto ("Copyrights");

WHEREAS, the Security Agreement was recorded in favor of Security Agent in the United States Patent and Trademark Office on April 7, 1998 on Reel No. 1717, Frame No. 0001, and in the United States Copyright Office on March 31, 1998 on Volume No. 3414, Page No. 1; and

WHEREAS, Security Agent wishes to formally release and reconvey to each Grantor the security interest in all of such Grantor's right, title and interest in and to the Trademarks and Copyrights.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Security Agent does hereby release and forever discharge and reconvey to each Grantor all of Security Agent's security interest in all of such Grantor's right, title and interest in and to the Trademarks and Copyrights; Security Agent does further acknowledge and affirm that all of the rights and remedies of Security Agent with respect to the security interest concerning the Trademarks and Copyrights have been and are hereby extinguished; and Security Agent does agree that it will, upon the reasonable request of Grantors, and at Grantors' expense, execute and deliver, or cause to be executed or delivered, any and all documents and take any and all actions that may be necessary or desirable to Grantors, its successors, assigns and legal representatives, to perfect the release of the security interest hereunder.

IN WITNESS WHEREOF, Security Agent has caused this Release of Security Interest to be executed by its duly authorized officer on the 4th day May, 2000.
