## ASSIGNMENT

**THIS AGREEMENT** (this "Agreement") effective as of December 15, 1999, is made by and between Infonautics Corporation, a Pennsylvania corporation, with a place of business at 900 West Valley Road, Suite 1000, Wayne, Pennsylvania 19087, and BHW/INFO/EDCO.COM, LLC, ("Edco"), a Delaware limited liability company, with a place of business at 1209 Orange Street, Wilmington, Delaware 19801.

**WHEREAS**, Infonautics Corporation was the owner and then-current user of the service marks listed on Exhibit "A" hereto and the goodwill associated therewith (collectively, the "Property"), and had applied for registration of the service marks listed on Exhibit "A" with the United States Patent and Trademark Office, both of which have matured into registrations as listed on Exhibit "A";

**WHEREAS**, as of December 15, 1999, Edco acquired by assignment from Infonautics Corporation ownership of all right, title and interest in the Property, and succeeded to the relevant portions of Infonautics Corporation's business to which the Property pertained as required by 15 U.S.C. §1060;

**WHEREAS**, the parties wish to confirm and acknowledge in writing the assignment and Edco's acquisition and ownership of all right, title and interest in the Property;

**NOW, THEREFORE**, in consideration of the sum of One Dollar (\$1.00) and the terms and conditions contained herein and for other good and valuable consideration, the legal sufficiency of which is hereby acknowledged by the parties, the parties hereto, intending to be legally bound, agree as follows:

Infonautics Corporation hereby sells, assigns, transfers, conveys, sets over and delivers to Edco the whole and entire right, title and interest in and to the Property (consisting of the service marks listed on Exhibit "A", together with any goodwill associated therewith), *nunc pro tunc*, now for then, effective as of December 15, 1999, for whatever purposes Edco desires.




