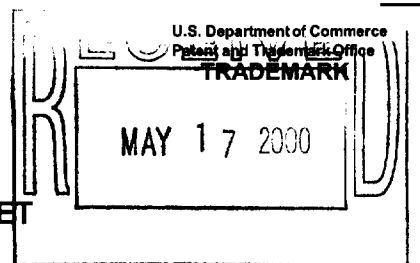



ARTICLES OF INCORPORATION

Allan Berman and Denise Berman certify that:


1. They are the President and Secretary of Imtec Products, Inc., a California corporation (the "Corporation").
2. Article First of the Articles of Incorporation of this Corporation is deleted in its entirety and a new article inserted to read as follows:  
  

"First. That the name of this Corporation shall be and hereby is IMTEC ACCULINE, INC."
3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of the Corporation is 360,000 shares of Common Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%).

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
