FIRST: The name of the Corporation is SII Acquisition, Inc..

SECOND: In order to change the name of the Corporation to Sports Im
Inc., Article 1 of the Articles of Incorporation of the Corporation is hereby amended i
entirety to read as follows:

"Article 1. The name of the corporation shall be
Sports Image, Inc. (the "Corporation")."
