The undersigned corporation hereby submits these Articles of Amendment for the purpose of amending its articles of incorporation:

1. The name of the corporation is EARNHARDT ACQUISITION, INC.

2. The following amendment to the articles of incorporation of the corporation was adopted by its directors and shareholders on the 23rd day of December, 1994, in the manner prescribed by law:

The name of the corporation shall be changed from Earnhardt Acquisition, Inc. to Sports Image, Inc.

3. The number of shares of the corporation outstanding at the time of such adoption was 500,000; the number of votes entitled to be cast thereon was 500,000; and the number of votes indisputably represented by a written consent of shareholders was 500,000.

4. The number of votes cast for such amendment was 500,000; and the number of votes cast against such amendment was 0.

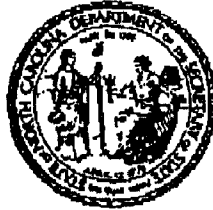

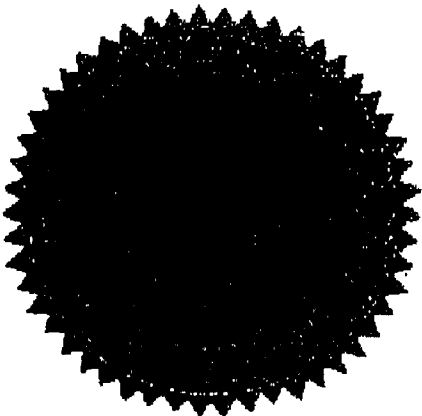
