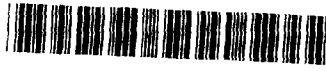

**ARTICLES OF AMENDMENT OF  
AMENDED AND RESTATED ARTICLES OF INCORPORATION OF  
PAKHOED DISTRIBUTION CORPORATION**

ARTICLES OF AMENDMENT of the Amended and Restated Articles of Incorporation of Pakhoed Distribution Corp. (the "Corporation") are herein executed by said Corporation, pursuant to the provisions of RCW 23B.10.060, as follows:

FIRST: The name of the Corporation is Pakhoed Distribution Corporation

SECOND: Article I of the Amended and Restated Articles of Incorporation is amended to read as follows:

The name of this corporation is Vopak Distribution Corporation.

THIRD: This amendment does not provide for an exchange, reclassification or cancellation of issued shares.

FOURTH: The date of the adoption of said Amendment by the Directors of said Corporation was the 9th day of December, 1999.
