ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
AMATEUR HOCKEY ASSOCIATION OF THE UNITED STATES, INC.

TO: Department of Consumer and Regulatory Affairs
Washington, D.C. 20001

Pursuant to the provisions of the District of Columbia Non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Amateur Hockey Association of the United States, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act:

Article 1 of such Articles of Incorporation is hereby amended to read in its entirety as follows:

"1. The name of the Corporation is USA Hockey, Inc."

THIRD: The amendment was adopted in the following manner:

The amendment was adopted at a special meeting of the Board of Directors held on January 11, 1992, and received the vote of a majority of the Directors in office, there being no members of the Corporation having voting rights in respect thereof.
