CERTIFICATE OF MERGER
OF

INSIDETHEWEB, INC.
(A New York Corporation)
WITH AND INTO
ITW NEWCORP, INC.
(A Florida Corporation)

Under Section 907 of the New York Business Corporation Law

ITW NewCorp, Inc., a corporation organized and existing under the laws of the State of Florida ("ITW"), does hereby certify:

FIRST: Pursuant to a Plan of Merger duly adopted, and upon the filing of this Certificate of Merger, InsideTheWeb, Inc., a New York corporation, ("InsideTheWeb") shall be merged with and into ITW (the "Merger"), with ITW being the surviving corporation in the Merger.

SECOND: The designation and number of outstanding shares of each class of stock of each corporation which is a party to the Merger is as follows:

- ITW has one hundred (100) outstanding share of common stock.
- InsideTheWeb has one hundred (100) outstanding share of common stock.

THIRD: The Merger of InsideTheWeb with and into ITW, is permitted by, and in compliance with, Sections 902, 903 and 907 of the New York Business Corporation Law and Section 607.1107 of the Florida 1989 Business Corporation Act.

FOURTH: The Merger has been approved by the sole shareholder of InsideTheWeb in accordance with paragraph (a) of Section 902 of the New York Business Corporation Law.

FIFTH: ITW is a corporation organized and existing under the laws of the State of Florida, incorporated on March 9, 1999. ITW has not and does not plan to file an application to do business in New York, and hereby affirmatively declares that it will not do business in the State of New York until such time as an application for such authority shall have been filed with the Department of State of the State of New York.

SIXTH: InsideTheWeb filed its Certificate of Incorporation with the Department of State of the State of New York on August 5, 1998, and under the name of Inside the Web, Inc.

SEVENTH: ITW hereby expressly:

- (1) agrees to be served with process in the State of New York, with respect to any action or special proceeding for the enforcement of any liability or obligation of InsideTheWeb previously amenable to suit in this state, and for the

enforcement, as provided by the New York Business Corporation Law, of the right of shareholders of InsideTheWeb to receive payment for their shares against ITW.

(2) agrees that, subject to the provisions of Section 623 of the New York Business Corporation Law, it will promptly pay to the sole shareholder of InsideTheWeb, the amount, if any, to which such shareholder shall be entitled under the provisions of the New York Business Corporation Law, relating to the right of shareholders to receive payment for their shares.

(3) designates the Secretary of State of the State of New York as ITW's agent upon whom process against it may be served in the manner set forth in paragraph (b) of Section 306 of the New York Business Corporation Law, in any action or special proceeding. The Secretary of State should mail a copy of any process so served to ITW at the following address:

(4) certifies that, all fees and taxes (including penalties and interest) administered by the department of taxation and finance which are then due and payable by InsideTheWeb have been paid and that a cessation franchise tax report (estimated or final) through the anticipated date of the Merger (which return, if estimated, shall be subject to amendment) has been filed by InsideTheWeb; and

(5) certifies that, it will within thirty days after the filing of this Certificate of Merger file the cessation franchise tax report, if an estimated report was previously filed, and promptly pay to the department of taxation and finance all fees and taxes (including penalties and interest), if any, due to the department of taxation and finance by InsideTheWeb.
