**TERMINATION AND RELEASE OF SECURITY INTEREST**

This **TERMINATION AND RELEASE OF SECURITY INTEREST** is made as of this 2 day of ~~January~~, 2000 by **CITIZENS BANK OF MASSACHUSETTS**, a Massachusetts bank having its head office at 28 State Street, Boston, Massachusetts (successor by merger to USTrust) (the "Bank").

WHEREAS, the Bank is the holder of a security interest (the "Security Interest") in certain assets of **L.B. EVANS' SON COMPANY LIMITED PARTNERSHIP** (the "Borrower") pursuant to a Demand Loan and Security Agreement - Accounts Receivable and Inventory and a Supplementary Security Interest -- Goods and Chattels, each dated June 3, 1996 between the Borrower and USTrust; and

WHEREAS, USTrust merged with and into Citizens Bank of Massachusetts and Citizens Bank of Massachusetts succeeded to all of USTrust's rights, title and interest in and to the Security Interest and it continues to hold the Security Interest; and

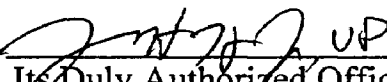
WHEREAS, the Borrower is conveying certain of its assets to **DANIEL GREEN COMPANY** (the "Purchaser"); and

WHEREAS, the Borrower is repaying its obligations to the Bank and has requested a termination of the Security Interest.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby represents and warrants that the above recitals are true and accurate and effective immediately, the Bank hereby terminates and forever discharges the Security Interest and any other liens, security interests, claims or rights of any kind which it may have in or to any of the Purchaser's assets and all other rights the Bank may have against the Borrower, and acknowledges that the assets being conveyed to the Purchaser are free and clear of the Security Interest. The Bank agrees to execute such other documents and provide such other assurances to carry out the intent of this Termination and Release.

IN WITNESS WHEREOF, the Bank has executed this Termination and Release under seal as of the date first written above.

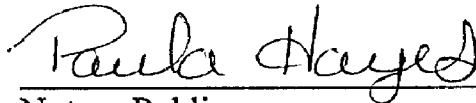
