

We have discovered that an inadvertent typographical error was made on the Recordal Cover Sheet with respect to the above-referenced assignment. A copy of the Recordal Cover Sheet submitted 06/03/99 is attached for your review. In this document the assignee is shown as TRELLEBORG WHEEL SYSTEMS AMERICAS.

We are also enclosing a copy of the "Certificate of Amendment of Certificate of Incorporation" which is the document which was submitted to the Assignment Division under cover of the aforementioned Recordal Cover Sheet. As you will see from the highlighted section of the "Certificate of Amendment" the correct name of the company to whom the trademarks have been assigned is in fact TRELLEBORG WHEEL SYSTEMS AMERICAS, INC.. When the Recordal Cover Sheet was prepared the term "Inc." did not print on the sheet and was therefore inadvertently omitted.
