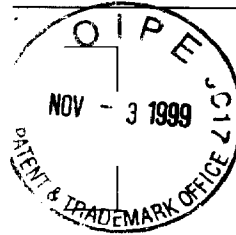

Upon the indefeasible cash payment in full of all Obligations (as such term is defined in the Agreement), the Agent will take whatever actions are necessary at the Grantors' expense to release or reconvey to the Grantors all right, title and interest of the Grantors in and to the Trademarks.

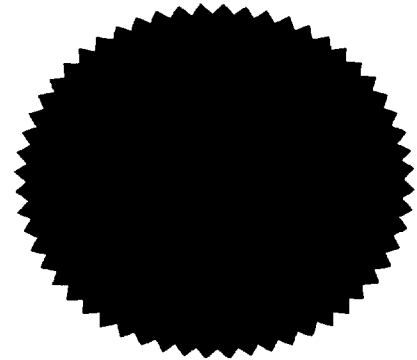

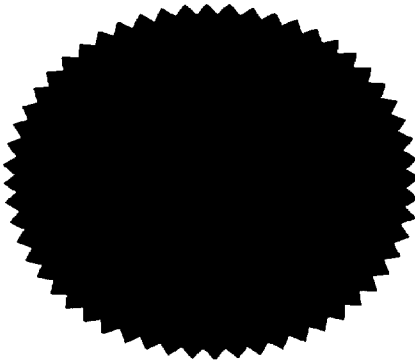
