

ACOUISITION AGREEMENT

This Agreement among SmarterKids.com, Inc., a Delaware corporation ("Buyer"); Smart Kids Company, Inc., a Connecticut corporation ("Smart Kids Company"); S.K.C., Inc., a Connecticut corporation ("SKC"); and Mary DeSilva, being the owner of all of the outstanding capital stock and other equity interests in Smart Kids Company and SKC (the "Stockholder"). Smart Kids Company, SKC and the Stockholder are referred to herein together as "Sellers."

In consideration of the covenants and conditions set forth in this Agreement, the parties agree as follows:

- 1. Purchase of Trademarks and Other Assets. (a) Sellers hereby sell, transfer and assign to Buyer all right, title and interest owned by them or any of them throughout the world in the trademarks, tradenames, domain names and other assets (the "Assets") listed on Schedule 1.
- (b) The Assets shall include, in addition to the Assets listed in Schedule 1, all trademarks, domain names, service marks, trade dress, logos, tradenames and service names, all copyrights, and all other proprietary rights and moral rights relating to the Assets (including without limitation associated goodwill and remedies against infringements thereof, rights to damages for the past infringement thereof, including any infringement by Buyer, and rights of protection of an interest therein under the laws of all jurisdictions), all registrations and applications for registration thereof, and all copies and tangible embodiments thereof. The Assets shall not include the assets listed on Schedule 2.
- Subject to the terms and conditions of this agreement, each party will use its best efforts to take, or cause to be taken, all actions and to do, or cause to be done, all things necessary or desirable under applicable laws and regulations to consummate the transactions contemplated by this Agreement. Sellers and Buyer each agree to execute and deliver such other documents, certificates, agreements and other writings and to take such other actions as may be necessary or desirable in order to consummate or implement expeditiously the transactions contemplated by this agreement and to vest in Buyer good and marketable title to the Assets. Sellers also shall execute such specific assignments of title as shall be requested by Buyer. If any of the Sellers after the date hereof acquires any additional interest in the Assets, or acquires any interest in trademarks, tradenames, domain names or other intellectual property containing the words "smart," or "smarter," alone or in any combination with "kids" or "children," as one word or multiple words, with or without additional words, or any word, term, name, symbol, or device, or any combination thereof that sounds similar to, looks similar to, or otherwise is likely to cause confusion, or to cause mistake, or to deceive as to the affiliation, connection, or association of such Seller with, respect to any of the Assets or the trademark SMARTERKIDS, such Seller agrees to assign such interest to Buyer without further consideration.
