

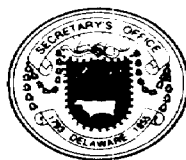

**Pursuant to Title 12, Section 3815
of the Delaware Code and Chapter 182, Section 2
of the Massachusetts General Laws**

NYTRNG Services, a Delaware Business Trust ("Services"), desires to merge with and into NYT Management Services, a Massachusetts Business Trust ("NYTMS") pursuant to the provisions of Title 12, Section 3815 of the Delaware Code (the "Merger"), and NYTMS hereby certifies as follows:

FIRST: The names and states of incorporation of the Constituent Parties which plan to merge hereby (the "Constituent Parties") are as follows:

<u>Name</u>	<u>State of Formation</u>
NYTRNG Services	Delaware
NYT Management Services	Massachusetts

SECOND: An Agreement and Plan of Merger, dated as of December 30, 1999, between Services and NYTMS (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the Constituent Parties in accordance with the requirements of Title 12 Section 3815 of the Delaware Code and Chapter 182, Section 2 of the Massachusetts General Laws.

THIRD: The surviving entity shall be NYT Management Services (the "Surviving Entity").

FOURTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Entity. The address of the principal place of business of the Surviving Entity is 135 Morrissey Boulevard, Boston, MA 02107-2378.

FIFTH: A copy of the executed Merger Agreement will be furnished by the Surviving Entity, on request and without cost, to the sole stockholder of either of the Constituent Parties.

SIXTH: The Surviving Entity does hereby agree that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of Services; and does hereby irrevocably appoint the Secretary of State of the State of Delaware as its agent to accept service of process in any such action, suit or proceeding. The address to which a copy of such process shall be mailed by the Secretary of State of the State of Delaware: 135 Morrissey Boulevard, Boston, MA 02107-2378.

SEVENTH: The Merger Agreement between the Constituent Parties provides that the Merger herein certified shall be effective at 4:00 p.m. on December 30, 1999 in the State of Delaware.
