ASSIGNMENT

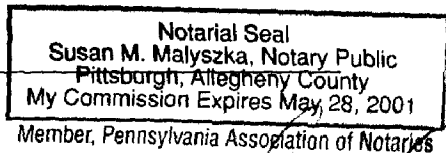
