

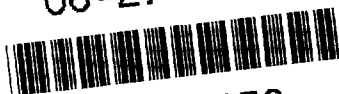

RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST is made as of ____ day of February, 2000, by U.S. Music Corporation, a Wisconsin corporation ("U.S. Music"), and Washburn International, Inc., an Illinois corporation ("Washburn").

WITNESSETH:

WHEREAS, U.S. Music and Washburn are parties to (i) that certain Asset Purchase Agreement dated April 24, 1995 (the "Asset Agreement"); (ii) that certain Security Agreement dated April 24, 1995 (the "Security Agreement") and (iii) that certain Assignment of Trademark Agreement dated April 24, 1995, (the "Assignment"), pursuant to which Washburn incurred certain liabilities to U.S. Music and granted a security interest in and collateral assignment of the trademark RANDALL, including U.S. Registration No. 1,801,062 therefor and the goodwill of the business associated therewith, trade names, product names, logos, drawings and schematics used in the Randall product line and all proceeds of the foregoing (the "Trademark").

WHEREAS, the Assignment was recorded in the Patent and Trademark Office on May 22, 1995; and

WHEREAS, Washburn has performed all of its obligations pursuant to the Security Agreement;

WHEREAS, Washburn has requested that U.S. Music release its security interest in the Trademark and reassign the same to Washburn;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

U.S. Music hereby releases its security interest in and collateral assignment of the Trademark and all right, title and interest in and to the same hereby revert to Washburn.
