RELEASE OF SECURITY AGREEMENT AND COLLATERAL ASSIGNMENT

This Release, dated March 30, 2000, is entered into by and between CONGRESS FINANCIAL CORPORATION (Central), an Illinois corporation ("Releasor"), having an office at 150 South Wacker Drive, Suite 2200, Chicago, Illinois 60606 and S.A.S.I. CORPORATION, an Illinois corporation ("Releasee"), with its chief executive office at 1700 St. Louis Road, Collinsville, Illinois 62234.

WHEREAS, Releasor entered into financing arrangements with Releasee, whereby certain loans and advances were secured by a Trademark Collateral Assignment And Security Agreement dated June 12, 1997, for the trademarks listed on the attached Exhibit A;

WHEREAS, the indebtedness to Releasor has been fully paid and Releasor wishes to release its security interest and collateral assignment in the trademarks, listed on the attached Exhibit A.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Congress Financial hereby agrees as follows:

1. Satisfaction of Obligation.

Releasor hereby acknowledges that all obligations owed by Releasee to Releasor have been satisfied and all debts have been paid in full.

2. Release of Assignment and Security Interest.

In consideration of the payment and satisfaction of all indebtedness, Releasor hereby releases Releasee from the

Trademark Collateral Assignment and Security Agreement dated June 12, 1997, which was recorded on or about July 14, 1997 at Reel 1609, Frame 0949, in the Official Records of the United States Patent and Trademark Office. This full and final release applies to all trademarks, listed on the attached Exhibit A.

3. Authority to Act.

Releasor hereby covenants that Releasor has full right to release the entire interest herein released and that Releasor has not executed and will not execute any agreement in conflict herewith.

4. Authorization to the Commissioner of Patents.

Releasor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, to release its previously filed Collateral Assignment and Security Agreement in accordance with the terms of this instrument. Releasor further agrees that it will execute such other documents as are reasonably required for the trademarks on Exhibit A to be conveyed to Releasee, free and clear of any right or interest of Releasor.

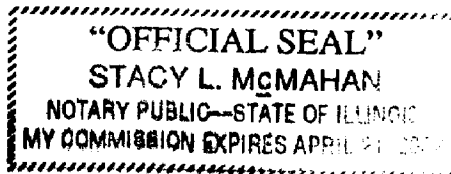
