TRADEMARK ASSIGNMENT

ASSIGNMENT AGREEMENT, effective as of December 31, 1999, by and between NCR Affiliate Servicer, Inc., a Delaware corporation qualified to do business in Florida with a principal place of business at 200 South Andrews Avenue, Fort Lauderdale, Florida, 33301 (“Assignor”) and NCRAS Management, LP, a Delaware limited partnership qualified to do business in Florida with a principal place of business at 200 South Andrews Avenue, Fort Lauderdale, Florida, 33301 (the “Assignee”).

WHEREAS, Assignor is the owner of the trademarks identified in Schedule A attached hereto and made a part hereof (the “Marks”); and

WHEREAS, Assignor desires to assign its right, title and interest in and to the Marks, together with the goodwill of the business pertaining thereto, to Assignee via 99.9% transfer to Assignee and simultaneous “pass through” transfer of 0.1% to NCRAS-GP, Inc., a Delaware corporation (the “General Partner”), and simultaneous transfer of such 0.1% from the General Partner to Assignee.

WHEREAS, Assignee desires to obtain ownership of the Marks in the foregoing manner, together with the goodwill of the business pertaining thereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys unto Assignee via the manner recited above all of its right, title, and interest in and to the Marks, together with the goodwill of all business symbolized by the Marks, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Agreement and sale had not been made, together with all claims for

damages by reason of past infringement of the Marks, with the right to sue for, and collect the same for its own use and behalf, and for the use and on behalf of its successors, assigns or other legal representatives of Assignee.
