## **ASSIGNMENT OF TRADEMARK**

This Assignment of Trademark, dated as of the 1st day of July, 1999, is made and entered into by and between Altronics, Inc., a Pennsylvania corporation ("Altronics"), and Domain Bank, Inc., a Pennsylvania corporation ("Domain Bank").

## WITNESSETH:

WHEREAS, Altronics is the owner and holder of a United States federal trademark registration of the name and mark "Domain Bank"; and

Neither the failure nor any delay by any party in exercising any right, power, or privilege under this Agreement will operate as a waiver of such right, power, or privilege, and no single or partial exercise of any such right, power, or privilege will preclude any other or further exercise of such right, power, or privilege or the exercise of any other right, power, or privilege.
- 4. <u>Severability</u>. The invalidity or unenforceability of any provision of this Agreement shall not affect the validity or enforceability of any other provisions of this Agreement, which shall remain in full force and effect.
- 5. <u>Binding Effect: Assignment.</u> This Agreement shall be legally binding upon and shall inure to the benefit of the parties hereto, their respective successors and permitted assigns. Neither party hereto may assign this Agreement or any rights or obligations set forth herein, in whole or in part, without the prior written consent of the other party.
- 6. <u>Governing Law.</u> This Agreement will be governed by the laws of the Commonwealth of Pennsylvania without regard to conflicts of laws principles, and jurisdiction of any dispute shall lie with a Court of competent jurisdiction located in Pennsylvania.


