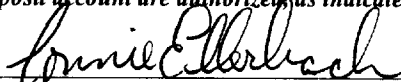


Steve Siltanen and Bruce Pincus certify that:

 "ONE: The name of the corporation is PC-Doctor, Inc."
3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.
4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The corporation has only one class of shares and the number of outstanding shares is 120,000,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required.
