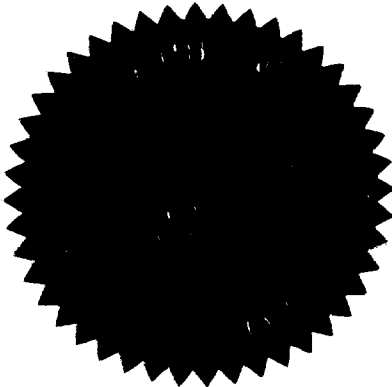

OF AMERICAN WATER SKI ASSOCIATION, INC.,

Pursuant to the provisions of the New Jersey Nonprofit Corporation Act, the undersigned executes and adopts the following amendment to the restated Certificate of Incorporation on behalf of the American Water Ski Association, Inc.:

1. Article I is amended to read as follows:

ARTICLE I - NAME

State Treasurer

The name of this corporation is USA WATER SKI, INC.

2. The corporation has members.

3. This amendment was adopted at a semi-annual meeting of the Board of ~~Directors~~ Trustees on August 9, 1999, and is to be effective on the date of filing.
