

ASSIGNMENT OF TRADEMARK

WHEREAS, K-WAY PRODUCTS, INC., a corporation of the state of Illinois, hereinafter called "SELLER", is the owner of the entire equitable and legal right, title and interest, by virtue of SELLER having adopted with continuous use, in and to the mark which is registered in the United States Patent and Trademark Office under U.S. Trademark Registration No. 880455, registered on November 11, 1969 (hereinafter, the "K-Way Mark"); and

WHEREAS, SYCA SYSTEMS, INC., an Illinois corporation, hereinafter called "PURCHASER", is desirous of acquiring the entire equitable and legal right, title and interest, throughout the world, in and to the K-Way Mark including U.S. Trademark Registration No. 880455, together with the goodwill appurtenant thereto.

NOW, THEREFORE, for the good and valuable consideration as set forth in a separate agreement between the parties entitled "Asset Purchase Agreement", receipt of which is hereby acknowledged, SELLER does hereby sell, assign, transfer and set over unto PURCHASER, all of SELLER's right, title and interest for the United States, its territories, dependencies and possessions, and for all other countries throughout the world, in and to the K-Way Mark and U.S. Trademark Registration No. 880455, and all common law trademark rights in said mark for the K-Way Mark, together with the goodwill of the business symbolized by the K-Way Mark and the trademark registration thereon, the same to be held and enjoyed by PURCHASER, PURCHASER's successors and assigns, for PURCHASER's own use and behalf and for the use and behalf of PURCHASER's successors and assigns, as fully and entirely as the same would have been held and enjoyed by SELLER, if this Assignment had not been made, together with all claims for damages by reason of past, present or future infringement of the K-Way Mark and the trademark registration thereon, and the right to use and collect the same for PURCHASER's own use and behalf, and for the use and behalf of PURCHASER's successors and assigns.

IN WITNESS WHEREOF, SELLER has caused this Assignment to be made and executed by its duly authorized officer, as the date indicated hereinbelow.

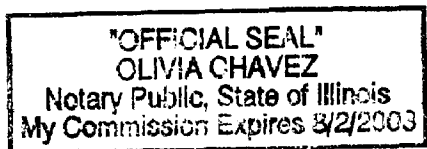
