

TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made as of April 25, 2000, by Spectrum International Holdings, Inc., a Delaware corporation ("Assignor"), in favor of Streater, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor entered into an Asset Purchase Agreement, dated as of April 7, 2000 (the "Agreement"), among Assignor, Rapid Rack Holdings, Inc., a Delaware corporation f/k/a Streater, Inc. ("Seller"), Assignee, and L.A. Darling Company, a Delaware corporation, pursuant to which Seller sold to Assignee and Assignee purchased from Seller certain assets of Seller, including its Proprietary Rights (as defined in Section 2.1(m)(i) of the Agreement);

WHEREAS, the Proprietary Rights acquired from Seller included the trademark "STREATER STORE FIXTURES" and Design, U.S. trademark Serial No. 75-633704 (the "Trademark");



NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, its successors, legal representatives and assigns, all of Assignor's right, title and interest in and to the Trademark together with the goodwill associated with the Trademark and the registration thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), the same to be held and enjoyed by Assignee, for its own use and on behalf of its successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made.

Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee, as assignee of the U.S. trademark Serial No. 75-633704 for the sole use and enjoyment of Assignee, its successors, legal representatives and assigns.
