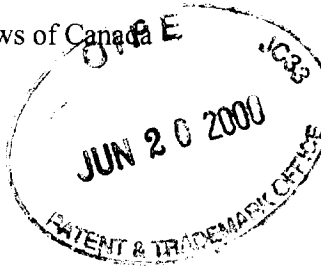


**SECURITY AGREEMENT SUPPLEMENT**

This COMPANY PATENT AND TRADEMARK SECURITY AGREEMENT SUPPLEMENT, dated as of March 31, 2000 is delivered pursuant to sections 6(d) and 6(e) of that certain Company Patent and Trademark Security Agreement (U.S.), dated as of February 12, 1998 (as it may be from time to time amended, modified or supplemented, the "**Security Agreement**"), by and among Mitel Corporation, as Grantor, and Canadian Imperial Bank of Commerce, as Secured Party. Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

Subject to the terms and conditions of the Security Agreement, Grantor hereby grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the Collateral listed on Supplemental Schedules I and II attached hereto, in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located. All such Collateral shall be deemed to be part of the Collateral and hereafter subject to each of the terms and conditions of the Security Agreement.
