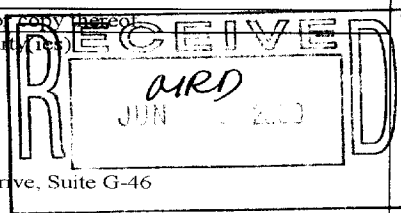

successors, assigns and legal representatives.


