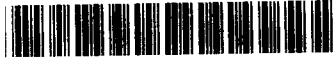

## Assignment of Trademark and Trademark Registration


