

RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made this 17th day of December, 1999 by General Electric Capital Corporation, a New York corporation ("GECC"), as Collateral Agent for itself and certain Lenders. Capitalized terms used herein without definition are deemed to have the respective meanings set forth in the September 6, 1996 Security Agreement (as defined herein);

WHEREAS, reference is made to that certain Trademark, Patent and Copyright Security Agreement dated September 6, 1996, as amended and restated from time to time, from Authentic Fitness Products Inc. as Borrower and the Grantors named therein to GECC for itself and certain Lenders (the "September 6, 1996 Security Agreement"), recorded in the United States Patent and Trademark Office on or about October 1, 1996 at Reel 1510, Frame 0762;

WHEREAS, reference is made to that certain Notice of Security Interest in U.S. Trademarks dated December 23, 1998, from Authentic Fitness Products Inc. as Borrower, and the Persons (other than GECC) listed in the signature pages thereto (the Borrower and such Persons each being a "Grantor", and collectively being the "Grantors") to GECC (the "December 23, 1998 Notice of Security Interest"), recorded in the United States Patent and Trademark Office on or about January 12, 1999 at Reel 1836, Frame 0364;

WHEREAS, in connection with the Credit Agreement referenced in the September 6, 1996 Security Agreement, as amended and restated from time to time (the "Credit Agreement"); and in connection with the Restated Credit Agreement dated as of March 18, 1998 referenced in the December 23, 1998 Notice of Security Interest, as amended

or restated from time to time (the "Restated Credit Agreement"), the Grantors have pledged and conditionally assigned to GECC for its benefit and the ratable benefit of the other Secured Parties, a security interest in, and first priority lien on all of the Grantors' rights, title and interest in and to certain collateral, whether then owned or after acquired;

WHEREAS, Schedule A attached hereto is a true and correct copy of the United States Trademark Registrations and Applications against which the September 6, 1996 Security Agreement was recorded;

WHEREAS, Schedule B attached hereto is a true and correct copy of the after acquired United States Trademark Registrations and Applications against which the December 23, 1998 Notice of Security Interest was recorded (the United States Trademark Registrations and Applications of Schedules A and B hereto shall collectively be referred to as the "Secured Property");

WHEREAS, in accordance with the terms of the Credit Agreement and the Restated Credit Agreement, the Borrowers have satisfied all of their outstanding Obligations under the September 6, 1996 Security Agreement and the December 23, 1998 Notice of Security Interest, and in connection therewith, the Borrower has requested and GECC, as Collateral Agent has agreed to release its security interest and lien on the Secured Property; and

WHEREAS, GECC represents that it, as Collateral Agent, has not sold, assigned, pledged or otherwise transferred or encumbered all or any part of its interest in the Secured Property, and that it has the full power and authority to make this Release of security interest in Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, GECC, as Collateral Agent, hereby releases and terminates all right, title and interest that GECC received pursuant to the September 6, 1996 Security Agreement and the December 23, 1998 Notice of Security Interest, including but not limited to any interest in the property identified in Schedules A and B hereto.
