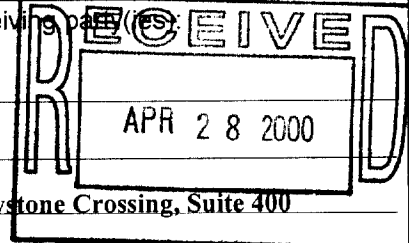

## ASSIGNMENT OF REGISTERED MARK
