Pursuant to Section 264 of the Delaware General Corporation Law and Section 17552 of the California Limited Liability Company Act, the undersigned do hereby certify the following:

1. The name and state of domicile of each of the constituent entities is as follows:
Surviving Entity: Kurzweil Applied Intelligence, Inc., a Delaware corporation ("KAI").
Disappearing Entity: Tiksoft LLC, a California limited liability company ("Tiksoft").
2. An Agreement of Merger, dated March 25, 1999 (the "Agreement"), has been approved, adopted, certified, executed and acknowledged by and between KAI and all of the members of Tiksoft, pursuant to which Tiksoft shall be merged with and into KAI, in accordance with Section 264 (c) (2) of the Delaware General Corporation Law.

5. Pursuant to the Agreement, the effective date of the Merger is March 31, 1999.

7. A copy of the Agreement will be furnished by KAI on request and without cost to any of its stockholders and/or any of the members of Tiksoft.
8. The Secretary of State of California shall serve as the statutory agent for KAI upon whom any process, notice or demand against either Tiksoft or KAI may be served for any

prior obligations for so long as any liability remains outstanding against Tiksoft or KAI in the State of California. Process may be forwarded to the address listed in Section 5, above.

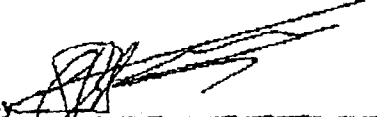
