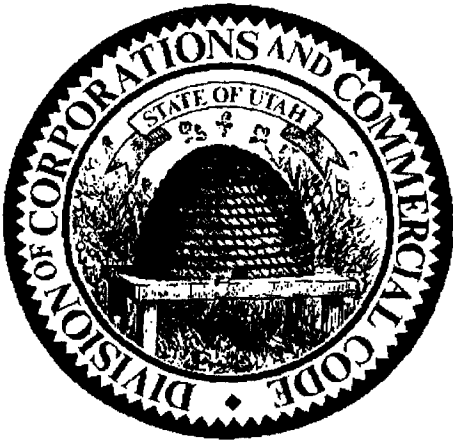

Pursuant to the provisions of Section 16-10a-1003 of the Revised Business Corporation Act of the state of Utah, the undersigned Corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation which change the name of the Corporation.

ARTICLE ONE

The name of the Corporation is Management Dynamics, Inc.

ARTICLE TWO

The holders of all issued and outstanding shares of capital stock of the Corporation adopted the following amendment to the Articles of Incorporation of the Corporation, which amends ARTICLE ONE of the Articles of Incorporation to read in its entirety as follows:

"The name of the Corporation is Bibliostat.com Corporation."

ARTICLE THREE

The amendment to the Corporation's articles of incorporation set forth in Article Two, above, was adopted by the holders of all issued and outstanding shares of capital stock of the Corporation as of February 17, 2000.

ARTICLE FOUR

The number of shares of common stock of the Corporation outstanding and entitled to vote at the time of such adoption was 950,000. No voting groups were entitled to vote separately on the amendment. All of the outstanding shares of capital stock of the Corporation voted to approve the amendment. The number of votes cast for the amendment was sufficient to approve the amendment.
