

WHEREAS, WISCONSIN TISSUE MILLS INC., a Delaware corporation, having a principal address at P.O. Box 489, Menasha, Wisconsin 54952 ("Assignor"), is the owner of the entire right, title, and interest in and to and has used the trademarks and service marks identified in attached Schedule A ("Trademarks"); and

the same to be held and enjoyed by Assignee, for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, for the full life of each of the Trademarks as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made. This Assignment includes the right to file additional Trademark registration applications under any convention or treaty, to claim priority in such applications based upon current Trademark applications and registrations, and to sue, seek injunctive relief, and collect damages and profits for past infringement.

Assignor authorizes the United States Patent and Trademark Office and comparable government authorities in other countries to transfer by assignment to Assignee any and all existing Trademark registrations and applications and to issue to Assignee all new Trademark registrations hereafter granted.






