Pursuant to the provisions of Title 29, Chapter 3 of the District of Columbia Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is Marketing and Management Information, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on February 29, 2000 in the manner prescribed by the Code of Laws of the District of Columbia.
