

**ASSIGNMENT AND RELINQUISHMENT
OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This Assignment and Relinquishment of Security Interest in Patents and Trademarks, dated as of April 23, _____, 19996 is made by Chemical Bank, a New York banking corporation ("Chemical"), as administrative agent (in such capacity, the "Administrative Agent") for the banks and other financial institutions (the "Lenders") from time to time parties to that certain Credit Agreement, dated as of July 1, 1993 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Sybron International Corporation, a Wisconsin corporation and successor to Sybron Corporation (the "Parent"), Ormco Corporation, a Delaware corporation ("Ormco"), Kerr Corporation (formerly known as Kerr Manufacturing Company), a Delaware corporation ("Kerr"), Nalge Company, a Delaware corporation ("Nalge"), Erie Scientific Company, a Delaware corporation ("Erie"), Barnstead Thermolyne corporation, a Delaware corporation ("Barnstead") (Ormco, Kerr, Nalge, Erie and Barnstead are collectively referred to herein as the "Subsidiary Borrowers"), the Lenders and the Administrative Agent.

WHEREAS, pursuant to the Credit Agreement, the Parent entered into that certain Parent Security Agreement, dated as of July 1, 1993, made by the Parent in favor of the Administrative Agent for the benefit of the Lenders, whereby the Parent granted to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in, inter alia, all Patents and Trademarks and Patent and Trademark Licenses (as such terms are therein defined) then owned or at anytime thereafter acquired by the Parent or in which the Parent then had or at anytime in the future acquires any right, title or interest;

WHEREAS, pursuant to the Credit Agreement, the Parent and the Subsidiary Borrowers caused the Grantors (as defined in the Subsidiaries Patent and Trademark Assignment and Security Agreement) to enter into the Subsidiaries Patent and Trademark Assignment and Security Agreement, dated as of July 1, 1993, whereby each Grantor granted to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in inter alia, all Patents and Trademarks and Patent and

Trademark Licenses (as such terms are therein defined), then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time in the future may acquire any right, title or interest, including, without limitation, the Patent and Trademarks and Patent and Trademark Licenses included on Schedule I and Schedule II thereto;

WHEREAS, the Subsidiaries Patent and Trademark Assignment and Security Agreement was recorded by the United States Patent and Trademark Office as to patents as of August 20, 1993, at Reel 6667, Frames 0903, et seq., and as to trademarks as of August 20, 1993, at Reel 1023, Frames 0009, et seq.; and

WHEREAS, Chemical, as Administrative Agent for the Lenders, wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge by the Administrative Agent of the aforementioned security interests and any other such property interests that may have been conveyed in the Subsidiaries Patent and Trademark Assignment and Security Agreement, dated as of July 1, 1993, ("Collateral") and the assignment of its interest in such Collateral back to the respective Parent or Subsidiary Borrower Grantor from which each such respective item of property was conveyed to Lenders by the Subsidiaries Patent and Trademark Assignment and Security Agreement.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Chemical, as Administrative Agent for the Lenders, (1) hereby relinquishes, releases and discharges its security interest in all such Collateral, including that set forth in Exhibit A annexed hereto, without representation, warranty or recourse (express or implied), and (2) hereby sells, assigns and transfers to its Grantor thereof, its entire right, title and interest in and to Patent and Trademarks and Patent and Trademark Licenses set forth in Exhibit A and in and to the subject matter disclosed in, and all Letters Patents Domestic and Foreign issued or to be obtained on, the Patents and Patent Applications set forth in Exhibit A, including all rights and interests with priority rights under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperative Union, European Patent Convention, Common Market Convention, or any other Convention or Union for each country of said Convention or Union; and we do hereby authorize and request the Commissioner of Patents to issue the Letters Patent granted on said application and all future patents

granted upon the subject matter disclosed therein to the above named Assignee, its legal representatives and assigns.

FURTHER, Chemical, as Administrative Agent for the Lenders, hereby authorizes the recording by any representative of any of the Parent and Subsidiary Borrower Grantors of a copy of this Assignment and Relinquishment of Security Interest in Patents and Trademarks for any one or more of the items of Collateral listed on Schedule 1, by replacing such schedule with one listing only such one or more items, and by designating thereon the name of the Parent or Subsidiary Borrower Grantor thereof to which the security interest is being hereby relinquished and the interest is being hereby assigned.
