## TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Geo-Con, Inc., a corporation formed under the laws of Pennsylvania, located at 4075 Monroeville Boulevard, Suite 400, Corporate Building II, Monroeville, Pennsylvania, 15146 ("Mortgagor"), owns the trademarks and trademark applications shown in the attached Schedule A (the "Trademarks"), for which there are recordings or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Mortgagor does hereby assign unto Agent and grant to Agent, for its benefit and for the ratable benefit of Lenders, a security interest in and to the Trademarks, the goodwill of the business symbolized by the Trademarks, and the registrations and applications therefor, which assignment and security interest shall secure all the Liabilities as defined in the Agreements and in accordance with the terms and provisions thereof.

Mortgagor expressly acknowledges and affirms that the rights and remedies of Lenders and Agent with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.


