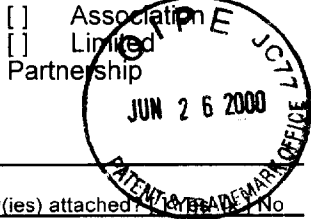

TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS Nunn Acquisition Corp., an Ohio corporation with its principal business address at 1400 Dublin Road, Columbus, Ohio 43215 ("NAC"), owns United States federal and common law rights in and for the trademark service mark LAND CRUISER for "modified self-propelled buses" and related goods and services, and for other goods and services on which or with which the mark LAND CRUISER has been used by NAC and/or its predecessors and/or licensees (the "Trademark"), and U.S. Trademark Registration No. 721,813 (Registered September 21, 1961; referred to herein as "Registration No. 721,813");

WHEREAS NAC's wholly owned subsidiary, Custom Coach Corporation, an Ohio corporation with its principal business address at 1400 Dublin Road, Columbus, Ohio 43215 ("CCC") has used in the U.S. since at least December 14, 1956, and is currently using, the mark LAND CRUISER in connection with modified self-propelled buses and related goods and services;

WHEREAS CCC currently uses the mark LAND CRUISER under a license from NAC;

WHEREAS NAC and CCC warrant that the Trademark, the registration thereof, and the rights therein are valid and subsisting, are not the subject of any proceeding in the U.S. Patent and Trademark Office or in any court, administrative, or arbitration proceeding, and that the exclusive rights to use the Trademark have been made incontestable under Section 15 of the Lanham Trademark Act, and that NAC owns the Trademark and all associated goodwill, and Registration No. 721,813;

WHEREAS Toyota Motor Corporation, a Japanese corporation with its principal business address at 1, Toyota-cho, Toyota-shi, Aichi-ken, Japan 471 ("TMC") wishes to purchase from NAC all of its rights, title, and interest in and to the Trademark and all goodwill associated with the Trademark and Registration No. 721,813;

WHEREAS CCC is a party to this Trademark Assignment Agreement in the event that it owns any rights, title, or interest in or to the Trademark, including but not limited to goodwill and/or residual goodwill;

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged by NAC and CCC, NAC and CCC hereby assign, transfer, and quitclaim to TMC (1) U.S. Trademark Registration No. 721,813, (2) all of NAC's and CCC's rights, title, and interests in and to the Trademark and all goodwill associated with and represented by the Trademark, including but not limited to all goodwill established through CCC's use of the Trademark on and in connection with modified self-propelled buses, related goods and services, all other goods and services on which or with which the mark LAND CRUISER has been used by NAC, CCC, and/or their predecessors and/or licensees, and any and all goodwill owned by NAC and/or CCC and established through TMS's use of the Trademark on and in connection with a class of vehicles currently known within the automotive industry as "sport utility vehicles", and in connection with related goods and services, and (3) all claims and causes or

rights of action in law or in equity to sue and recover damages or to obtain any other available remedies for past, present, or future infringement of the Trademark.

IN WITNESS WHEREOF, and intending to be legally bound, NAC and CCC have caused this Trademark Assignment Agreement to be executed by their duly authorized representatives, as set forth below.

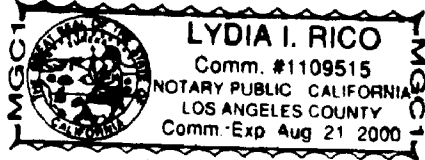

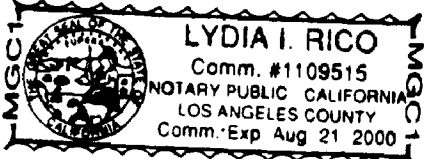
