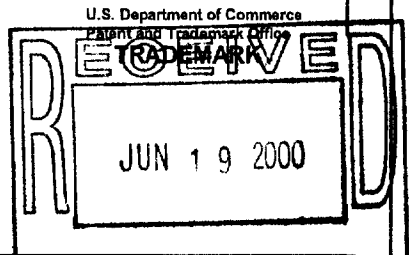

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

Pursuant to Section 607.1006 of the Florida Business Corporation Act (the "Act"), MessageQuest, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: MessageQuest, Inc.
2. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety to state as follows:

**"ARTICLE ONE
NAME OF CORPORATION**

The name of this corporation is: CommerceQuest, Inc."


3. Article III of the Corporation's Articles of Incorporation is hereby amended in its entirety to state as follows:

**"ARTICLE THREE
CAPITAL STOCK**

The aggregate number of shares of stock that this corporation is authorized to issue is 40,000,000 shares of common stock, par value \$.002 per share."

4. The shares of the Corporation issued and outstanding at the time of adoption was 12,274,580 and the number of shares entitled to vote thereon was 12,274,580.
5. The foregoing amendments to the Corporation's Articles of Incorporation were adopted and approved by all of the stockholders of the Corporation on the first day of June, 1999, pursuant to Section 607.1003(6) of the Act, and the number of votes cast for the amendments was sufficient for approval.
6. The foregoing amendments to the Corporation's Articles of Incorporation shall become effective upon the filing of these Articles of Amendment to the Articles of Incorporation with the Florida Department of State.
