INTELLECTUAL PROPERTY ASSIGNMENT

INTELLECTUAL PROPERTY ASSIGNMENT, dated as of February 10, 2000, is made and entered into by and between ZD Inc., a Delaware corporation ("Assignor"), in favor of WBT Operating LLC, a limited liability company organized under the laws of the State of Delaware ("Assignee").

Assignor and WP Education Holdings LLC ("WP Education") have entered into a Purchase Agreement, dated as of November 17, 1999 and amended as of the date hereof (as so amended, the "Purchase Agreement"), whereby Buyer agreed to acquire certain assets, and assume certain of the obligations and liabilities, of Seller upon the terms and conditions more fully set forth therein. Capitalized terms used herein but not defined herein are used herein as defined in the Purchase Agreement. WP Education has assigned part of its rights and obligations under the Purchase Agreement to Assignee in accordance with Section 9.1 of the Purchase Agreement, and as a result Assignor will be required to transfer a part of the Intellectual Property that constitutes Transferred Assets to Assignee.

Accordingly, it is agreed as follows:

1. Assignor hereby sells, assigns and transfers, effective on the date hereof, to Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Trademarks that constitute Transferred Assets but do not incorporate the words "Logical Operations" or "Cobb", as fully and entirely as the same would have been held and enjoyed by Assignor had this Intellectual Property Assignment not been made, including the following to the extent they constitute Transferred Assets:

(a) all Trademarks, together with the goodwill of the business, or portion thereof to which the Trademarks pertain, symbolized thereby, registered with or filed or recorded in the United States Patent and Trademark Office or in any foreign jurisdiction and any applications for registration (including intent-to-use applications), including any URL defined as a Copyright by the Purchase Agreement, but excluding those Trademarks that incorporate the words "Logical Operations" or "Cobb"; such registrations and applications are identified on Schedule A to this Intellectual Property Assignment; and

(b) all claims and causes of action in favor of the Assignor heretofore accrued or hereafter accruing with respect thereto for past, present and future misappropriation, infringement or other violation of proprietary or other rights in such Trademarks but excluding any recovery (whether by settlement or otherwise) of attorneys' fees and expenses incurred by Assignor in connection with the Pacifica Litigation.

2. Assignor hereby requests and authorizes the Commissioner of Patents and Trademarks of the United States of America and any foreign register of any and all foreign Trademark rights transferred hereunder, whose collective duties include issuing trademark registrations, to issue the Certificate of Registration, Renewal or Assignment, for any trademark registration, or trademark registration resulting from any application, that is part of the Intellectual Property transferred hereunder, to Assignee, or its successors and assigns, in accordance with the terms of this instrument. Assignor hereby requests and authorizes any other official throughout the world whose duty it is to register and record ownership of trademarks to record Assignee, or its successors and assigns, as the assignee and owner of the right, title and interest assigned under this Intellectual Property Assignment.

3. Assignor agrees to execute and deliver at a future date any further documents or instruments of transfer or assignment that Assignee may reasonably request for the purpose of recording these assignments or otherwise carrying out the intent of the Purchase Agreement.

4. This Intellectual Property Assignment is an instrument of transfer contemplated by, and is executed pursuant to, the Purchase Agreement and nothing contained herein shall be deemed to modify any of the provisions of the Purchase Agreement or any rights or obligations of the parties under the Purchase Agreement.
