DREAMWORKS INTERACTIVE L.L.C.

ASSIGNMENT AGREEMENT

This Assignment is entered into as of February 15, 2000 (the "Effective Date") by and between Dreamworks Interactive L.L.C., a Washington limited liability company, with offices at 640 North Sepulveda Boulevard, Los Angeles, California 90049 ("DWI") and Electronic Arts Inc., a Delaware corporation, with its principal business offices at 209 Redwood Shores Parkway, Redwood City, CA 94065 ("EA").

RECITALS

A. DWI is a limited liability company whose sole member and manager is EA.

B. DWI and EA, as DWI's sole member, have determined that it is in the best interests of both companies that DWI's intellectual property assets be assigned to and held by EA.

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows:

1. ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS

DWI hereby assigns to EA all of DWI's right, title and interest, of whatever kind and nature forever and throughout the universe, in and to any and all of DWI's intellectual property assets and rights (including but not limited to, copyrights, moral rights, patents, patent applications, trademarks, service marks, trade names and trade secrets, and specifically including those trademark registrations and applications listed on Exhibit A attached hereto, and those copyright registrations and applications listed on Exhibit B attached hereto) all rights to receive any of the foregoing, and all proceeds thereof (the "DWI IP Assets"). The DWI IP Assets shall also be deemed to include the results and proceeds of the services of all persons rendering services in connection with the intellectual property assets, the rights of which are being assigned hereunder.

2. FURTHER DOCUMENTS

DWI agrees to execute and deliver to EA such further instruments as may be reasonably required to carry out or effectuate the purposes and intent of this Assignment.

3. ASSUMPTION OF OBLIGATIONS

EA hereby agrees to assume all of DWI's current and future obligations and liabilities related to the DWI IP Assets, whether certain or contingent, including but not limited to all liabilities for taxes, liabilities under contracts, liabilities for any tort, malfeasance or omission committed by DWI (or any of DWI's officers or directors in the course of their duties for DWI), and other liabilities imposed by law, whether arising prior to the Effective Date or thereafter.
