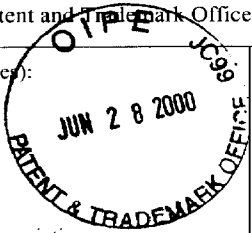



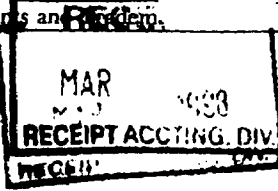

**CONFIRMATION ASSIGNMENT AND
RATIFICATION OF SECURITY INTEREST**

WHEREAS, Key Corporate Capital Inc., a Michigan corporation, having an address at 127 Public Square, Cleveland, Ohio 44114-1309 ("Key"), is the secured party under a Credit Facility and Security Agreement, dated as of February 26, 1998 and recorded at the U.S. Patent and Trademark Office ("PTO") as Collateral Assignment of Trademarks, Works and Applications for Trademarks, at Reel 1702, frame 0206 et seq., said agreement encumbering, among other things, the trademarks and registrations identified in the attached Schedule A (the "Marks and Registrations");

WHEREAS, Key recorded its security interest in the Marks and Registrations with the PTO by delivery of a Security Agreement and related recordation cover sheet misidentifying the conveyance of the Marks and Registrations as an "assignment" to Key rather than a "security agreement" granted in favor of Key; and

WHEREAS, Seco/Warwick of Delaware, Inc. a corporation of Delaware having its principal place of business at 180 Mercer Street, Meadville, Pennsylvania 16335 ("Seco/Warwick"), is desirous of confirming its ownership, subject to Key's security interest therein, of the Marks and Registrations, together with the goodwill of the business symbolized by the Marks and Registrations.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Key confirms that Key does hereby, subject to and except for Key's security interest in the Marks and Registrations,

assign and transfer unto Seco/Warwick all of its right, title and interest in and to the Marks and Registrations identified in Schedule A together with the goodwill of the business connected with the use of and symbolized by the Marks and Registrations; provided, however, that the assignment granted hereby shall not be deemed to impair, release or affect in any way Key's security interest in the Marks and Registrations.
