The undersigned certify that:


1. The name of the corporation is 20th Century Plastics, Inc.
2. Article I of the corporation's Articles of Incorporation, which relates to the name of the corporation, is hereby amended so as to read as follows:

"The name of the Corporation is Centis Inc."


3. The amendments herein provided for have been approved by the corporation's Board of Directors.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporation Code. The total number of outstanding shares of the corporation is 2,250,607.825 shares of Series A Common Stock, no par value per share, and 407,409 shares of Series B-1 Common Stock, no par value per share. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under the penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our knowledge.
