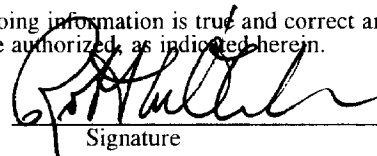

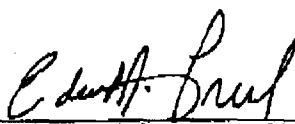

**FIRST:** That the Board of Directors of Financial Information Services Acquisition Corporation, by Written Consent in Lieu of Meeting of Board of Directors dated May 24, 1999, in accordance with the provisions of Section 242 of the DGCL, duly and unanimously adopted a resolution setting forth a proposed amendment to the Certificate of Incorporation of the Corporation, declaring such amendment to be advisable and directing that such amendment be submitted to and be considered by the sole stockholder of the Corporation for approval. Such resolution proposed to amend the Certificate of Incorporation of the Corporation as follows:

Article FIRST of the Certificate of Incorporation of the Corporation is hereby amended to read in its entirety as follows:


"The name of the Corporation is Mergent FIS, Inc.

**SECOND:** That thereafter, the sole stockholder of the Corporation duly approved said proposed amendment by written consent dated May 24, 1999 in accordance with Sections 228 and 242 of the General Corporation Law of the State of Delaware.

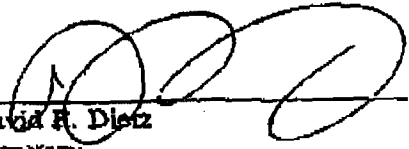
