INTELLECTUAL PROPERTY RELEASE

THIS RELEASE dated as of May 31, 2000, by The Chase Manhattan Bank, as Collateral Agent to the Lenders (as such terms are defined below). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

W I T N E S S E T H :

WHEREAS, HUNTSMAN PACKAGING CORPORATION, a Utah corporation ("Borrower"), Aspen Industrial, S.A. de C.V., a Mexico corporation (the "Mexico Borrower"), the LENDERS and THE CHASE MANHATTAN BANK, a New York banking corporation, as administrative agent (in such capacity, the "Administrative Agent") and as collateral agent (in such capacity, the "Collateral Agent") are party to that certain Credit Agreement dated as of September 30, 1997, as amended and restated as of May 18, 1998.

WHEREAS, Borrower, the Mexico Borrower and the U.S. Subsidiaries (together with Borrower and the Mexico Borrower, the "Grantors") and the Collateral Agent are party to that certain security agreement dated as of September 30, 1997, as amended and restated as of May 14, 1998 (the "Security Agreement"), recorded by the United States Patent and Trademark Office on July 17, 1998 at Reel No. 1756 and Frame No. 0578, and Reel No. 9405 and Frame No. 0489, and recorded by The Copyright Office on July 16, 1998, volume 3419, page 841, volume 3419, page 845 and pursuant to which, among other things, the Borrower and the Grantors granted a security interest to the Collateral Agent for the benefit of the Secured Parties in certain Collateral (as defined in the Intellectual Property Security Agreement), as described in Schedule I hereto, as security for the Obligations.


