

ASSIGNMENT OF U.S. PRINCESS TRADEMARKS

Pursuant to the CPHUS98 - Fairmont U.S. Transfer Agreement made and entered into as of the 1st day of October, 1999 between CP Hotels (U.S.) 1998 Inc., a Delaware corporation ("CPHUS98"), and Fairmont Hotels & Resorts (U.S.) Inc., a Delaware Corporation ("Fairmont U.S."), for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CPHUS98 does hereby assign, transfer, convey and deliver to Fairmont U.S. all rights, title and interest in and to the trademarks and service marks (the "Marks") set forth on Exhibit A attached hereto and incorporated herein by reference, together with the goodwill of the business connected with the use of and symbolized by the Marks and the registration of such Marks and any renewals thereof; and all rights, interests, claims and demands recoverable in law or equity that CPHUS98 has or may have in profits and damages for infringements or dilutions of the Marks occurring prior to, on or after the date hereof, including but not limited to the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Fairmont U.S., its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by CPHUS98 if this Assignment had not been executed.

CPHUS98 agrees to cooperate with Fairmont U.S., at Fairmont U.S.'s request and at CPHUS98's expense, to execute any and all documents or instruments, or to obtain any consents, in order to assign, transfer, perfect, record, maintain, enforce or otherwise carry out the intent of the terms of this Assignment with respect to the rights granted Fairmont U.S. hereunder. CPHUS98 hereby appoints Fairmont U.S. as CPHUS98's attorney-in-fact, with full authority in the place and stead of CPHUS98 and in CPHUS98's name, to take any of the foregoing actions in the event that CPHUS98 fails, refuses or is unable to do so for whatever reason. CPHUS98 hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof.

CPHUS98 agrees that Fairmont U.S. may cause this Assignment to be recorded in the United States Patent and Trademark Office and any other appropriate trademark or intellectual property registration office.
