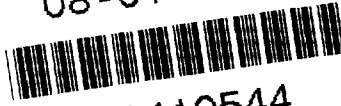

ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK is made as of June 15, 2000, by Orphan Medical, Inc., a Minnesota corporation ("Assignor"), to the Medical College of Hampton Roads, a political subdivision of the Commonwealth of Virginia ("Assignee").

Assignor is the exclusive owner of all of the right, title and interest in and to the "Mark" and the "Application," as those terms are defined below. Assignor desires to transfer to Assignee, and Assignee desires to acquire from Assignor, the Mark and the Application, together with the portion of Assignor's business to which the Mark pertains.

NOW THEREFORE, for and in consideration of the covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

- 1. Assignor hereby conveys, sells, transfers, assigns and delivers to Assignee, its successors and assigns, all the right, title and interest of Assignor in and to the CAPROGEL trademark (the "Mark"), together with the portion of Assignor's business to which the Mark pertains, and the Intent to Use application Serial No. 75/123251 filed by Assignor at the United States Patent and Trademark Office for the Mark on June 21, 1996 (the "Application").**
- 2. Assignee shall have all right to register, extend, renew, maintain, defend and enforce the Mark, the Application and any and all registrations resulting therefrom in its own name in the United States and any foreign country, and Assignor hereby agrees to execute any documents and perform any acts to enable and assist Assignee to register, extend, renew, maintain, defend and enforce the Mark, the Application and any and all registrations resulting therefrom and to confirm or record this Assignment in the United States and any foreign country.**
- 3. Assignor hereby assigns to Assignee, its successors and assigns all causes of action and claims of infringement of the Mark under the trademark laws of the United States, foreign countries and international trademark conventions and treaties that have accrued to Assignor as of the date hereof. Assignor hereby further agrees to cooperate fully with Assignee in the enforcement of all such causes of action and claims.**
- 4. Assignor hereby represents and warrants that (i) it is the exclusive owner of the Mark, and (ii) to the best of its knowledge, the Mark does not infringe upon any mark protected by the trademark laws of any country.**
- 5. Assignor hereby acknowledges and agrees that henceforth Assignee is the exclusive owner of the Mark, together with the portion of Assignor's business to which the Mark pertains, and the Application, and Assignor will refrain from using any trade name, trademark or service mark that is confusingly similar to the Mark assigned hereby.**

- 6. Assignor hereby agrees that this Assignment shall be binding upon its representatives, successors and assigns.
- 7. Assignor hereby agrees that this Assignment shall be governed by the laws of the Commonwealth of Virginia.

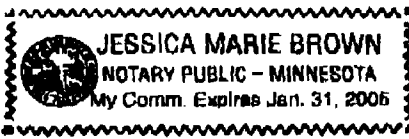


