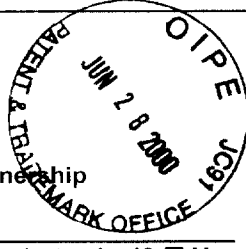



The rights transferred to ASSIGNEE hereunder shall include, without limitation, the right to recover for past, present and future infringement or other wrongful use or misappropriation of the TRADEMARKS.

ASSIGNOR covenants with ASSIGNEE that no assignment, grant, mortgage, license or other agreement affecting the rights and properties herein conveyed has been made to others by ASSIGNOR, and that full right to convey the same as herein expressed is possessed by ASSIGNOR.
