## U.S. TRADEMARK ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt for and sufficiency of which is hereby acknowledged, and intending to be legally bound, Assignor does hereby assign, transfer and deliver to Assignee the entire right, title and interest of Assignor in and to the Trademarks, including all common law rights connected therewith, together with the goodwill associated therewith, the registrations therefor and the right to sue and collect damages for the past infringement, in each case, free and clear of all liens, security interests and encumbrances and forever defends valid and indefeasible title in and to the Trademarks and such rights and goodwill.

Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks to record Assignee as the owner of the Trademarks and to issue to Assignee, in lieu of Assignor, in accordance with this instrument, all future certificates, notices and any other documents bearing on the Trademarks.

This instrument shall insure to the benefit of Assignee and its successors and assigns and shall be binding upon Assignor and its successors and assigns.
