ASSIGNMENT OF TRADEMARKS

2. Assignor and Assignee hereby consent to and request recordation of this Assignment and further authorize and request that all official documents and communications relating to said Marks issue and deliver to Assignee, its attorneys, agents, successors or assigns.

3. Assignor further agrees that it shall, upon request by Assignee, take such actions and execute such further documents or instruments as may be reasonably necessary or desirable to effectuate or record this Assignment, including, but not limited to, country-specific or translated documents or instruments.


