ASSIGNMENT OF INTELLECTUAL PROPERTY

This Agreement is made and entered into November ²⁷, 1999, by and between Advent Communications & Entertainment Company, a Nevada corporation, ("Assignor"), and Hurricane Harry's International, Inc., a Nevada corporation, ("Assignee"), who hereby agree as follows:

1. Assignment of Intellectual Property. Assignor hereby contributes, transfers, assigns and conveys to Assignee, effective as of October 8, 1999 (the "Effective Date"), all of Assignor's rights, title, and interest in and to all trade secrets, proprietary rights and knowledge, trademarks, trade names, copyrights, marks, symbols, logos, permits, and all applications therefor and registrations thereof, which the Assignor owns or has the right to use and which in any way relate to the Hurricane Harry's concept and all filings, registrations, or issuances of any of the foregoing with or by any federal, state, or local regulatory, administrative, or governmental office, including without limitation, the registered copyrights listed on EXHIBIT A, the copyright applications listed on EXHIBIT B, and the trademark applications listed on EXHIBIT C (the "Intellectual Property"), as described in the Subscription Agreement and Acknowledgment of Investment Intent (the "Subscription Agreement"), by and between Hurricane Harry's International, Inc. and Advent Communications & Entertainment Company, dated October 8, 1999.

2. Acceptance. Assignee hereby accepts the above-described assignment of the Intellectual Property as of the Effective Date.

3. Consideration. The Intellectual Property is being assigned by Assignor to Assignee as Assignor's contribution to the capital of Assignee in exchange for shares of Assignee's common stock, all as described in that certain Subscription Agreement, dated October 8, 1999.






