WHEREAS, the Debtor has fully satisfied certain of the Debtor's obligations to the Lender with respect to said loan and security agreements;



NOW, THEREFORE, the Lender states as follows:



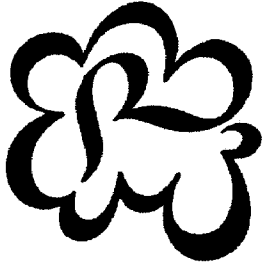

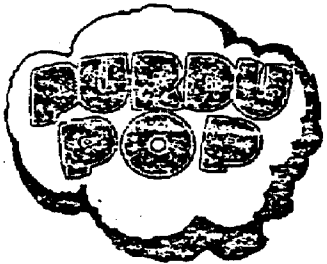
